CONSENT FORM IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 4 OF 2013 (POPIA)

You may revoke the consent you have given us in terms of this form at any time. Your revocation should be in writing and addressed to our information officer. Revoked consent is not retroactive and will not affect any past or existing use of your information.
