	PASSPORT VALID Valid passport for at least 6 months after the intended departure date.
$\sqrt{}$	ENTRY FEE £20.00 CASH ON ARRIVAL A fee of £20.00 is payable for all visitors disembarking at St Helena: persons under the age of 12 are exempted from this fee. CASH ONLY - in British Sterling, Saint Helenian Pounds, US Dollars (\$28.00), Euros (€25.00) and South African Rand (R400) - will be accepted for short term entry permit. The above £20.00 equivalents are subject to change as per the rate of exchange on the day of arrival.

# MEDICAL INSURANCE £175,000 COVERAGE

Valid medical insurance for at least £175,000 (or equivalent) which covers emergency medical treatment including aeromedical evacuation, or other means to pay for treatment to cover yourself for the duration of your stay. You may be asked to provide proof on arrival which must be in ENGLISH. Paper or electronic proof of insurance is accepted, but please remember to download the electronic proof of insurance to your mobile device prior to boarding the flight in South Africa – there is no free Wi-Fi at St Helena Airport and only one mobile phone service provider on Island (Sure South Atlantic Ltd)







#### **TRAVEL INSURANCE**

#### TO INCLUDE; MISSED DEPARTURE & DELAYED DEPARTURE COVER

Given the remote location of St Helena Island and the weekly flight to the Island, it is strongly recommended that you purchase travel insurance that includes both missed departure and delayed departure cover, to provide financial coverage in the event that the flight to or from St Helena is significantly delayed.



#### **BANKING**

### IF REQUIRED; VISIT THE BANK KIOSK AT ST HELENA AIRPORT ON ARRIVAL

There are currently no ATM cash machines on St Helena, and acceptance of credit and debit cards on Island is limited. Cash is the best form of making payments locally. The Bank of St Helena offers cash advances on major debit and credit cards, and UK clearing bank customers can cash UK cheques, up to the limit of the applicable cheque guarantee card. # DUTY FREE ALLOWANCES FOR YOUR INFORMATION

The following Duty Free Allowances are available to all visitors, aged 18 years or over:

Spirits, Strong Liqueurs: 2 Litres at 22% or below or 1 Litre exceeding 22%

Plus

2 Litres of Wine or 12 bottles/cans (340 ml size) Beer or Lager

And

250ml perfumed spirits or Eau de toilette

200 cigarettes or 250g tobacco

# **RETURNING ST HELENIANS**

## **SAINT STATUS LETTER**

If you are a St Helenian returning to the Island for a holiday or relocating from abroad, you will may be asked to show evidence that you have St Helenian status. St Helenians who are not normally resident on the Island but still have St Helenian status will also be required to show appropriate evidence. Please note that the place of birth showing on a passport as St Helena is not sufficient evidence that Saint Status is held.

For either of the above cases, St Helenian status can be shown by a 'permission to travel' letter from the appropriate authorities, a Declaration of St Helenian Status Certificate or a Certificate of St Helenian status issued by the St Helena Immigration Control Board. Partners and children of St Helenians can apply for a Spouse of Life Partner Exemption Certificate or a Dependent Exemption Certificate. Please be advised that if you are not in possession of any of the above documents you will be treated as a visitor and may not be permitted to board the aircraft if you cannot show St Saint Helenian Status or sufficient medical coverage.
